- 5. Review, discuss, and take appropriate action on the cash activity report for the District and its affiliates, including approving payments, and discuss and take further action with regard to any additional reporting or budget related matters.

 - a. Obtain legal advice from District Counsel related to agenda items 7, 8 and 9.
- 7. Consider approving Order Dividing SH130 Municipal Management District No. 1, Establishing Terms of Division, Creating HICAM Municipal Management District, Allowing for the Continuation of SH130 Municipal Management District, Appointing Directors and Establishing an Effective Date ("Division Order").
- 8. Consider authorizing execution of special warranty deed to HICAM Municipal Management District for conveyance of HICAM Property.
